World Summit on the Information Society

"Broad debate on how the Internet should be run and managed"

Intergovernmental process (UN Summit)

Decisions taken by states

Multi-stakeholder participation -

UN bodies, international organisations, NGOs, civil society, private sector





General Principles for Internet Governance

Par 29 Tunis agenda:

The international management of the Internet should be multilateral, transparent and democratic, with the full involvement of governments, the private sector, civil society and international organizations

Multilateral - Transparent - Democratic - Multi-stakeholder





- Importance of the Stability and Security of the Internet
- Mandate to UN Secretary General to convene a new forum for multi-stakeholder policy dialogue
- Process for 'enhanced cooperation'



IGF - mandate

Mandate of the IGF: (Par. 72 Tunis Agenda)

- a. **Discuss** public policy issues related to key elements of Internet governance in order to foster the <u>sustainability</u>, <u>robustness</u>, <u>security</u>, <u>stability and development</u> of the Internet;
- Facilitate discourse between bodies dealing with different cross-cutting international public policies regarding the Internet and discuss issues that do not fall within the scope of any existing body;
- c. **Interface with** appropriate inter-governmental organizations and other institutions on matters under their purview;
- d. Facilitate the exchange of information and best practices, and in this regard make full use of the expertise of the academic, scientific and technical communities;
- e. **Advise** all stakeholders in proposing ways and means to accelerate the availability and affordability of the Internet in the developing world;
- f. Strengthen and enhance the engagement of stakeholders in existing and/or future Internet governance mechanisms, particularly those from developing countries;



IGF - mandate

Mandate of the IGF: (Par. 72 Tunis Agenda)

- g. **Identify** emerging issues, bring them to the attention of the relevant bodies and the general public, and, where appropriate, make recommendations;
- h. Contribute to capacity building for Internet governance in developing countries, drawing fully on local sources of knowledge and expertise;
- i. **Promote and assess**, on an ongoing basis, the embodiment of WSIS principles in Internet governance processes;
- j. Discuss, inter alia, issues relating to critical Internet resources;
- k. **Help to find solutions** to the issues arising from the use and misuse of the Internet, of particular concern to everyday users;
- I. Publish its proceedings

- What after Vilnius?
- ⇒ Tunis Agenda gave the IGF a mandate for 5 years
- ⇒UN Secretary General to make a recommendation on the desirabilty of the continuation of the IGF
- ⇒ Consultation with IGF participants
- ⇒ Decision about a continuation of the IGF to be taken by the UN Member States



IGF – Review & Evaluation

CENTR supports the continuation of the IGF

recommendations:

- => Maintain the IGF as a **non-negotiating**, **discussion forum** where to embrace internet related matters in a constructive and cooperative manner;
- => Strengthen the **educative**, **collaborative** and **informative** principles;
- => Enhance the **follow up** process after every yearly meeting so that the outcome of any dialogue is properly spread;
- => Better enable **remote participation** and to ensure that all the various stakeholders are properly represented and their voice heard;
- => Empower the **Secretariat** to present regular reports on the regional and national IGF initiatives and to share them via the official IGF site:
